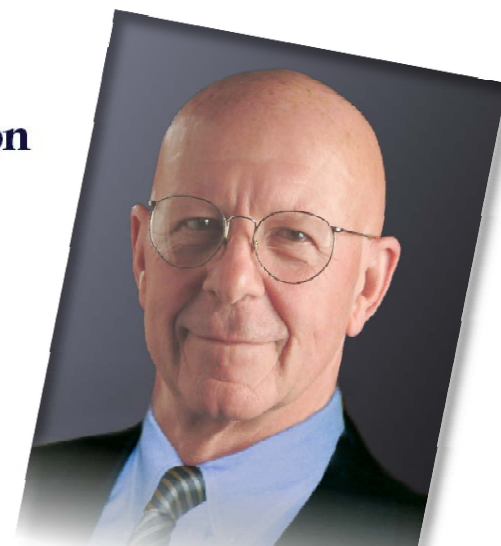

Judge Fitzsimmons' legal career began in 1978 as a public defender. In 1979, he entered private practice but returned to public service in 1986 as an Assistant District Attorney, Chief of Criminal Division, for St. Tammany Parish. From 1988-1995, he served as Judge in the 22nd Judicial District Court for St. Tammany Parish. He was elected to the First Circuit Court of Appeal in 1995, retiring in 2004. Judge Fitzsimmons was also an Adjunct Professor for Loyola University Law School's Legal Skills Program (1989-1990) and an instructor in the English departments of both Loyola University New Orleans (1972-1975) and Southeastern Louisiana University (1969-1972). He has been a speaker/presenter at numerous civic and legal conferences and meetings.
