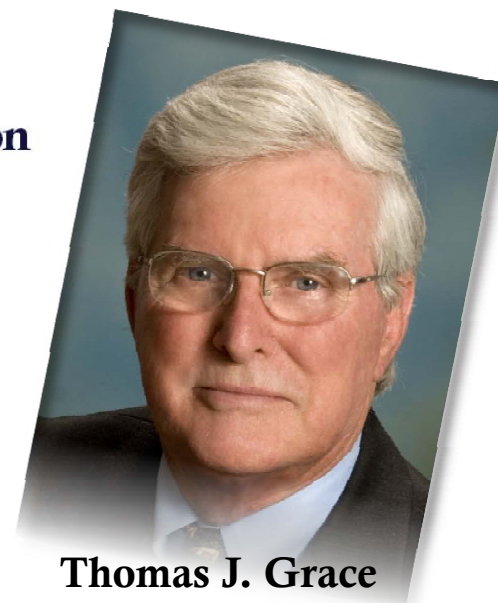

Practice

A full time mediator, Tom Grace has mediated almost 2,000 cases since beginning his mediation career in 1993. For seven years he was corporate counsel and a director for a publicly traded company, where he had primary responsibility for all of the company's contracts, franchise agreements, leases, insurance claims, and commercial disputes. After twenty years as a trial attorney, specializing in admiralty and maritime law and personal injury (doing both plaintiff and defense work) and four years as Magistrate Judge in Harahan, he entered mediation with training by AAA and advanced training with MAPS. His mediations have primarily involved complex, multi-party commercial disputes, maritime and oilfield litigation, personal injury matters, and insurance disputes. He is admitted to practice in all Louisiana State Courts, the United States Supreme Court, the United States Fifth Circuit Court of Appeals and all Federal District Courts in Louisiana.

Representative Matters
